- 3 Goals for the guidance of funding allocation (.ppt)
  - Continue implementing a guaranteed and viable curriculum
  - (Ongoing) Organize, operate, and refine intervention strategies that focus on improving mastery of standards through Formative and Summative assessments, Standards-Based grading, Implementation of high-value instructional strategies.

- Organize, operate, and refine extended learning and leadership opportunities for students who have demonstrated mastery of the standards; enrichment activities such as STEM, Science Olympiad, Coding, Art, etc.
